**PURPOSE:** The purpose of this program instruction is to rescind all NYSOFA issuances that are outdated and/or irrelevant.

**BACKGROUND:** Since NYSOFA was established under the federal Older Americans Act of 1965 and the Executive Law of New York State (now the New York State Elder Law), it has been publishing Program Instructions, Technical Assistance Memorandums, Information Memorandums, Advocacy Alerts, and Legislative Memorandum which are collectively known as Issuances. Over time many of these issuances have become outdated and/or irrelevant due to many factors such as changing laws, issuances that deal with a limited time frame, issuances regarding programs that no longer exist, etc.

NYSOFA reviewed the issuances published by the agency since its inception. NYSOFA has determined that any issuance no longer published on the NYSOFA website is rescinded and should no longer be followed or used by Area Agencies on Aging, their contractors, or the public. If an issuance does not appear on the NYSOFA website due to error, NYSOFA will publish the issuance on the NYSOFA website and will provide notice of such publication.
