SUBJECT: FY 2014 Final Long Term Care Ombudsman Program Allocations –
Title VII and State LTCOP

ACTION REQUESTED: Long Term Care Ombudsman Program (LTCOP) sponsors must ensure their 2014 LTCOP Support Agreement Title VII and State LTCOP budgets include final 2014 allocation amounts and their final 2013 Title VII carryover (if any) has been included in their 2014 Title VII budget. Each LTCOP sponsor must also ensure 2014 expenditures will meet or exceed the minimum Maintenance of Effort (MoE) requirement level.

PURPOSE: To transmit the final FY 2014 Title VII and State LTCOP allocation schedules.

BACKGROUND: NYSOFA received its' final FFY 2014 Title VII allotment from AOA and the 2014-15 State Budget was enacted including continued funding for the State LTCOP program. The final SFY 2014 State LTCOP appropriation is \$690,000, the same amount as in 2013. Therefore, the State LTCOP allocations are the same as those included on the tentative allocation schedule posted to the LTCOP website and communicated by Mark Miller's December 4, 2013 e-mail. NYSOFA received \$956,337 in FFY 2014 Title VII funding. This amount is \$14,709 less than the \$971,046 received for FFY 2013. Although the Title VII funding for FFY 2014 was reduced, our Office has supplemented the Title VII funding with a portion of its State level funds, thereby holding the LTCOP grantee funding at \$1,061,562, the same level as in 2013. The Title VII grantee allocation total includes \$1,005,562 in base funding and reporting supplements, plus a \$56,000 supplement to replace the State LTCOP reduction incurred in 2008. Therefore, the final FFY 2014 Title VII grantee allocations are the same as the 2014 tentative allocation schedule.

Attached are the final 2014 allocation schedules for the Title VII and State LTCOP. These schedules are the same as those posted to the LTCOP website and communicated by Mark Miller's December 4, 2013 e-mail. Many of the 2014-15 grantee Support Agreements are approved. With those approved agreements NYSOFA issued Title VII Notifications of Grant Award (NGAs) with a ceiling of approximately 25% of the total Title VII award. Shortly, each grantee with an approved Support Agreement will be issued their full year Title VII and State LTCOP NGAs.

The Title VII allocation schedule also includes Reporting Supplements of \$2,000 per program to pay for the renewal cost of the Ombudsmanager software and AgingNetwork.com. In addition to paying for these renewal costs, any remaining supplemental funds must be used to cover costs to send the necessary staff to the annual Ombudsman Training Conference. Any balance beyond that may be used on any other allowable LTCOP expenses.

Title VII Maintenance of Effort

Area Agency LTCOP sponsors must expend an amount equal to or greater than the amount listed on the MoE schedule in addition to their current Title VII expenditures. MoE levels may be met by LTCOP program expenditures under Title III-B, the NYS LTCOP program and other local funds expended on the LTCOP program. CAARS expenditure reports will be reviewed to ensure compliance with the MoE requirement. LTCOP sponsors must ensure that all LTCOP expenditures are appropriately reported on their CAARS quarterly reports. In addition to the specific MoE requirement, the Older Americans Act states that funds made available under Title VII shall supplement, and not supplant any federal, State or local funds expended by a state or unit of general purpose government (including an area agency on aging).
